Tender Notice Corrigendum

Reference: Tender ID No. 2024_MEA_764065_4, dated 15 July 2024

In addition to the terms outlined in the tender notice referenced above, the following terms are hereby added:

1. Earnest Money Deposit (EMD):

- Interested service providers must furnish an Earnest Money Deposit (EMD) of Rs. 25,000/- (Equivalent IDR 5,000,000/-).
- The EMD should be in the form of an Account Payee Demand Draft, Pay Order, or Bank Guarantee drawn in favor of "The Consulate General of India, Bali."
- The validity of the Demand Draft, Pay Order, or Bank Guarantee must be up to six months from the last date of bid submission.
- Bids submitted without the EMD will be summarily rejected.

2. Bid Withdrawal or Modification:

- Bidders are not permitted to withdraw their offer or modify the terms and conditions thereof.
- Failure to comply with the stipulations or withdrawal after quoting rates will result in the forfeiture of the bid security and will render the bidder ineligible for future bids with the Consulate General of India, Bali.

3. Performance Security:

- The successful bidder must deposit Performance Security amounting to a minimum of 3% of the contract value in favor of "The Consulate General of India, Bali."
- The Performance Security must be submitted in the form of a Demand Draft, Pay Order, or Bank Guarantee within fifteen days of the acceptance of the Letter of Award (LoA).
- The Performance Security should remain valid for sixty (60) days beyond the completion date of all contractual obligations of the service provider.
- If the contract is extended beyond the initial period, the Performance Security must be renewed accordingly. No interest shall be paid on the Performance Security.

4. Forfeiture of Performance Security:

- The Performance Security may be forfeited by order of the Competent Authority at the Consulate in the event of any breach, negligence, non-observance of contract terms, unsatisfactory performance, or non-acceptance of the work order.

- Upon contract expiry, a portion of the Performance Security deemed sufficient to cover any incorrect or excess payments made to the contractor shall be retained until the final audit report on the contractor's account is received and examined.

5. Failure to Provide Performance Security:

- If the Contractor fails to provide the Performance Security within fifteen days of the acceptance of the LoA, this will constitute a breach of contract.
- In such cases, the Client shall make alternative arrangements at the risk, cost, and expense of the Contractor.

Note: All other terms and conditions of the original Tender Notice remain unchanged.
